# Ministry Milestones

GCM celebrated 20 years in 2009

Great Commission Ministries exists to serve churches and ministries by mobilizing missionaries for the Great Commission. Our passion and hope is that through evangelism, discipleship and church planting we will be a part of seeing the next generation transformed through the Good News. 2009 was a year of vibrant ministry and we give God all of the glory for who He is, and what He has done.

In 2009 we celebrated our 20th anniversary. We are eternally grateful to those 23 men and women who were there at our beginnings in 1989. They responded to Jesus' call to 'follow Me' by serving as missionaries in their local churches. They are a strong witness and living example to the young men and women that are just now starting on their own path in ministry. John Hever, GCM Missionary for 20 years and pastor at h2o Church in Orlando expressed it this way: "Through GCM, God has given me the opportunity to fulfill my calling from Him, alongside men and women who are passionate for Christ." We look expectantly to the next 20 years and to what God is going to do through GCM!

With the faithful support and generous giving of our supporters we were able to send out 47 new missionaries to churches on college campuses, urban centers and international cities across the world. This accounted for eight percent growth in our overall missionary team. We continued our focus on recruiting, equipping and sending out new staff while building new ministry relationships, and the Lord has blessed those efforts.

Our missionaries on college campuses experienced tremendous fruit in 2009. GCM Churches experienced a 15 percent increase in Sunday attendance, 42 percent growth in small group attendance and a 21 percent increase in students engaged in leadership within their local church.



#### Dear friends of GCM,

Thank you for your faithful partnership with Great Commission Ministries. Through you, God graciously supplies the needed financial resources for this ministry. We never take this blessing for granted. As stewards of those resources, we take our responsibilities very seriously. Therefore, we want to keep you informed annually about the finances of the ministry that you support.

GCM maintains a high degree of internal financial control that assures good stewardship and prudent business practices. The 2009 financial records were audited by the independent certified public accounting firm of Capin Crouse LLP. (A copy of their auditor's report is always available upon request from GCM.) In addition, an Audit Review Committee reviews and approves the annual audit. This Committee meets twice a year to insure that the highest standards of financial integrity are consistently maintained and that GCM adheres to the requirements of the Evangelical Council for Financial Accountability (ECFA).
