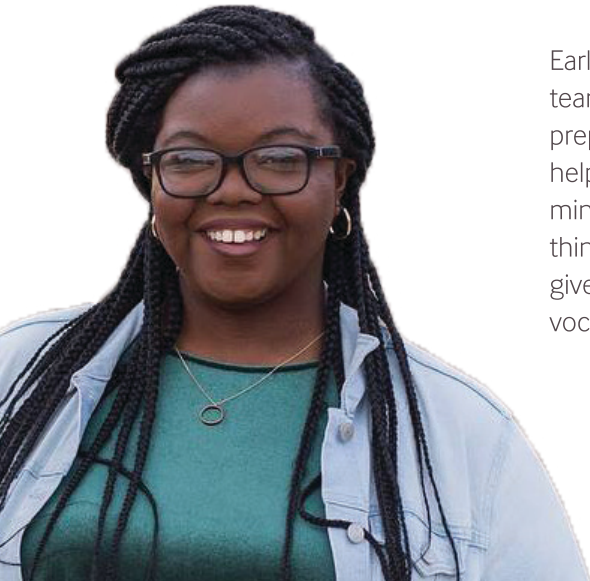




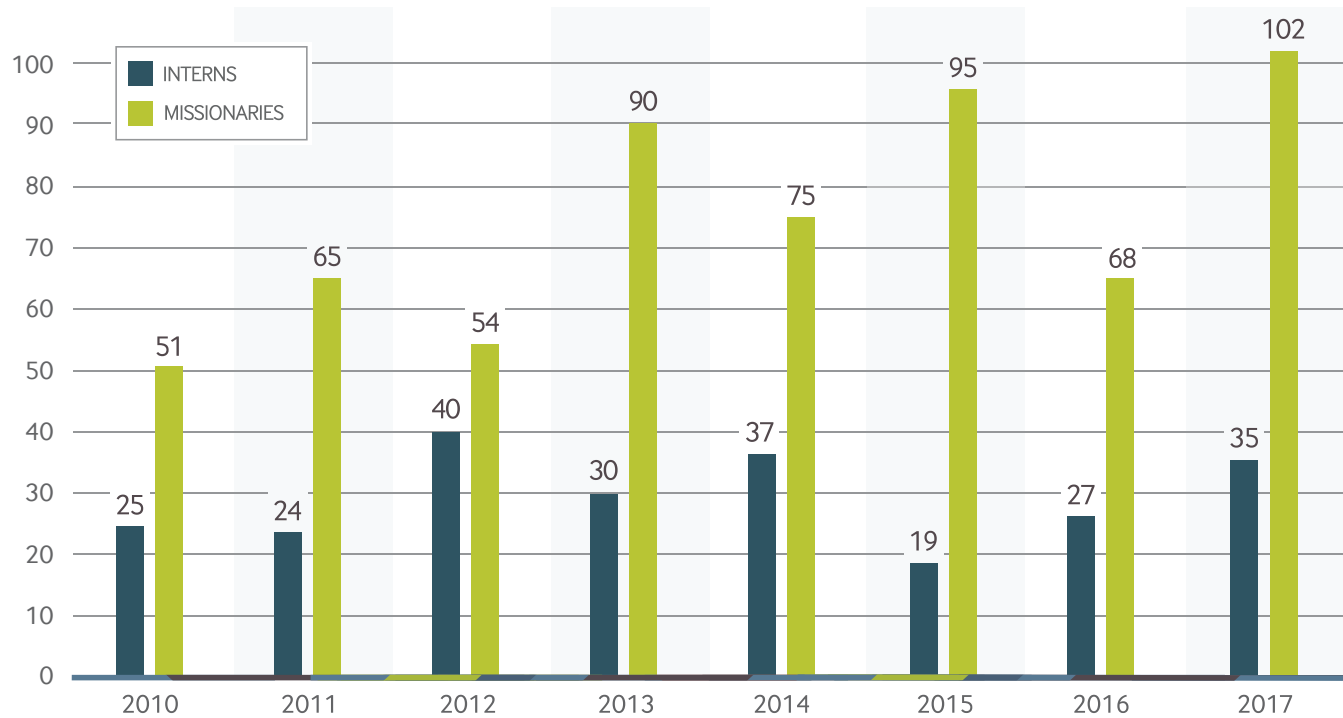
PURSHIA GAMBLES

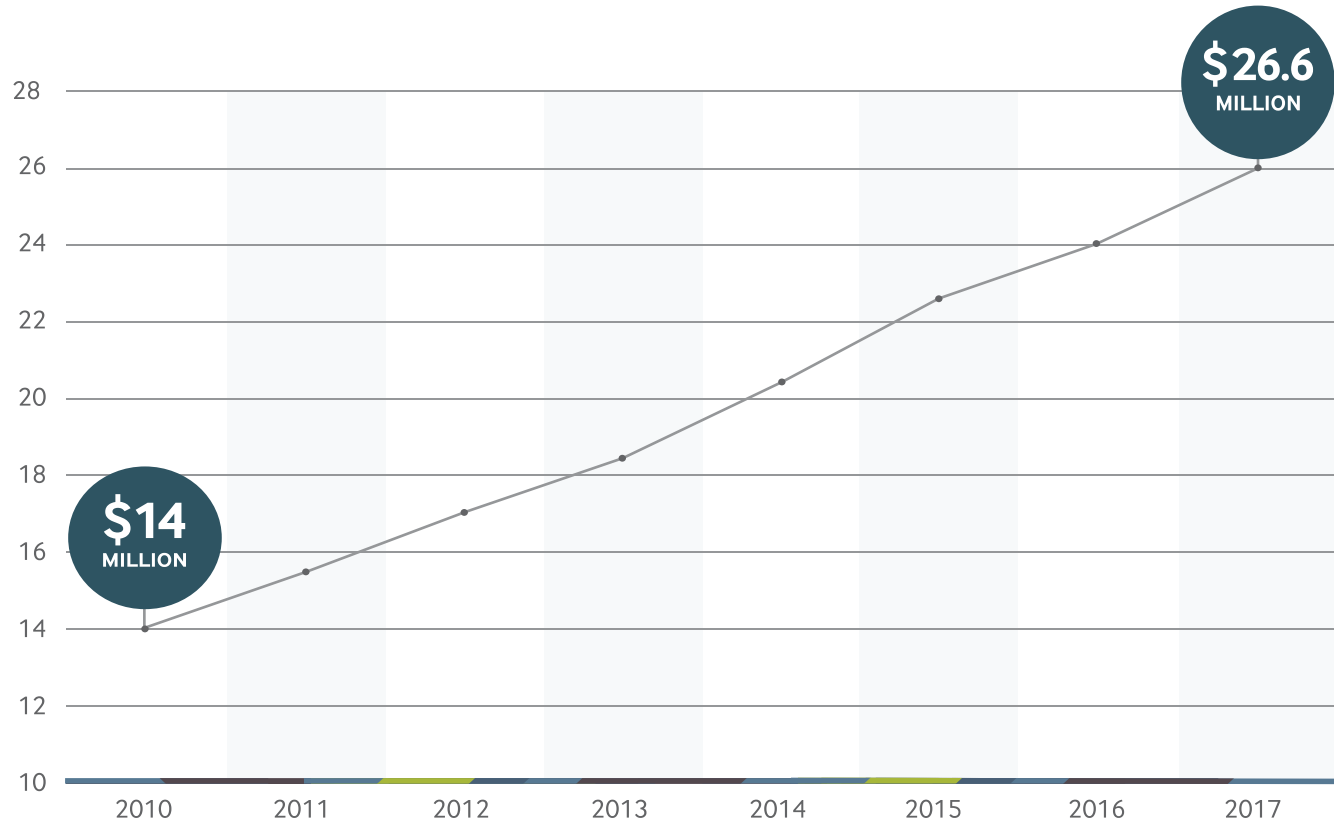

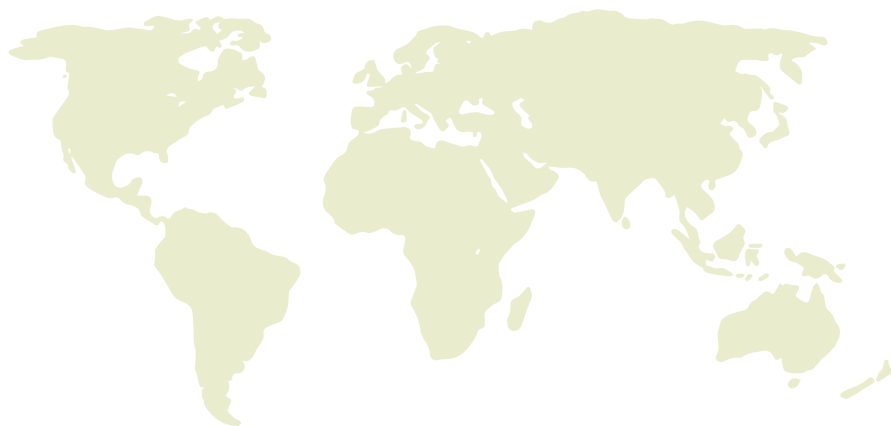
